- The" Mauro Bolognini Centre" of Pistoia represented by its founder members: Municipality and Province of Pistoia, Cassa di Risparmio di Pistoia e Pescia banking foundation, The local Trade, Crafts and Industrial Association and "Brigata del Leoncino" organizes its 4th competion of Short Film Festival dedicated to Mauro Bolognini aimed at short films of italian and foreign directors in any type of film or digital format.
- 2) Videos and Films completed later than January 1st 2008 can be entered. The running time cannot exceed 30 minutes, titles inclusive. Films exceeding the above mentioned running time can be exceptionally be admitted by the selection board.
- 3) To participate in the selection, the authors have to send 2 DVDs. The copies will not be returned, they will be part of the Mauro Bolognini Centre archives.
- 4) It is possible to enter only one film.
- 5) 2 DVD copies of the film are requested. Packages should be clearly marked by the title.
- 6) It is necessary to fill in the entry form describing the original format, the running time, the releasing year as well as the name and full address of either the author or a person in charge for the production. In order to facilitate a reliable transcription of the details in our official catalogues, candidates are requested to fill in the fields of the attached form properly. Selected significant pictures of the film are welcome.
- 7) The films must be delivered, together with the entry form signed by the author, to the following address: Centro Mauro Bolognini Corso Gramsci, 125 CAP 51100 Pistoia- ITALY. Candidates are requested to send their works and data by September 10th at the latest. The date will be certified by the original postmark.
- 8) The subtitled version is requested for non Italian films.
- 9) A qualified jury (Alberto Sironi director; Francesco Frigeri screenwriter; Manolo Bolognini Film producer; Siro Ferrone lecturer; Gabriele Cecconi art director) will select the admitted films and they will be included in events of the Short Film Festival on 26-27-28 November 2010. At the end of the film the jury will award the best film.
- 10)The best film prize consists of a two-thousand Euros check (2.000,00), a short stay for two people by the Hotel "La Bussola" in Amalfi and the Festival trophy.
- 11) Jury members take their decisions by secret ballot and the verdict issued is not subject to appeal. The jury cannot number among its members

voters interested in producing or distributing any of the films involved in the Festival competition.

- 12)Each candidate will timely receive a detailed and reliable copy of the event program.
- 13)Each author is held responsible for the contents shown in his/her work(s).
- 14)To take part in the competition, candidates must fully agree to the terms and conditions shown in this document. In the event of disputes or unforeseen circumstanstances, the jury reserves the right to resolve the issue.
